PROGRAMME

According to the valid UEG Technical Regulations (edition 2007) and FIG Code of points 2009-2012.

AGE

<u>Seniors:</u>	18 years or older (born in 1991 or before)
<u>Juniors:</u>	15 to 17 years (born in 1992, 1993, 1994)

Gymnasts have the right to participate if they reach the determined age during the year of the competition.

PROVISIONAL REGISTRATION

This form has to be received by the UEG Secretariat by **June 17th 2009** at the latest.

DEFINITIVE REGISTRATION

This form has to be received by the UEG Secretariat by **August 17th, 2009** at the latest.

NOMINATIVE REGISTRATION OF THE JUDGES

The nominative registration of the judges has to be received by the UEG Secretariat at the same time as the definitive registration, by **August 17th, 2009** at the latest.

NOMINATIVE REGISTRATIONS OF THE GYMNASTS AND OF THE OFFICIALS

This form has to be received by the UEG Secretariat by **October 27th 2009** at the latest.

PARTICIPATION LIMITS FOR COMPETITORS

If a competitor, after the drawing of lots, does not have a recovery time of 10 minutes at the minimum, he/she must give up a competition.

ENTRY FEES

CHF 100.- per individual, CHF 200.- per pair, CHF 300.- per trio, CHF 400.- per group. The entry fees have to be paid by **August 17th, 2009** to:

REGULATIONS

Both events will be organised according to the valid TR/UEG (edition 2007) and the FIG 2009-2012 Code of Points.

WORK PLAN

The participating federations will receive the work plan according to UEG-regulations.

JUDGES

According to the TR/UEG, all Federations taking part in the competitions and having a judge with a valid FIG brevet must make him/her available for the competition (minimum 1, maximum 2 judges).

PUBLICITY ON THE ATTIRE OF THE GYMNASTS

Federations wishing to display advertising motifs on attires used in competition by gymnasts and/or coaches must notify the Secretariat of the UEG by completing the enclosed form "Publicity on competition attire". The form must be received at the Secretariat of the UEG not later than **October 27th, 2009**.
